Procedure Concerning Child Allowance

The scheduled payment date for June is Monday, June 9. This will cover the period of April-May, 2025. After that, payments will be deposited on even-numbered months (i.e., February, April, June...)

Eligible ages	1st child, 2nd child	3rd child and later children
Under age 3	15,000 yen/month	30,000 yen/month
Age 3 to high school age*	10,000 yen/month	
From the end of the year (March 31) in which the child turns age 18 to the end of the year in which the child turns age 22	* Children are considered part of the birth order for the child allowance until the end of the year (March 31) during which they turn 22, even though the provision of the allowance ends after the first March 31 following their 18th birthday.	

* Children are considered to be "high school age" up until the first March 31 following their 18th birthday.

* Eligibility for the child allowance was expanded in October 2024. Please see the Ota City website for more details.

A Childcare Mama Can Provide Childcare for Your Child

Childcare Mamas can provide childcare for children of working parents, parents looking for work, and parents due to give birth. For more details, see the Ota City website or contact the Ota City Office.



Childcare locations: The Childcare Mama's home or a nursery room in an Ota City facility



23,000 yen per month for a maximum of 8 hours between 8:00 am and 5:00 pm.
After that, you will be charged an additional 250 yen per half hour.



Varies depending on the Childcare Mama.



Applications are accepted at the Nursery Services Division on the 3rd floor of the Ota City Office. Please arrive with your child. If you are working, you must provide a certificate of employment (Ota City form; not required if you have previously submitted it with an application to a licensed daycare center, etc., and it is still valid).

Procedure

Regarding the Status of Residence of Newborn Children

If you give birth in Japan, you may be required to apply for status of residence for your baby.
In the following cases, please apply for status of residence within 30 days of your baby's birth to receive a residence card for your baby.

- Your baby's nationality is not Japanese.
- You plan to stay in Japan for at least 60 days after your baby's birth.

Inhabitant Tax Certificates Can Be Issued

Certificates containing inhabitant tax information can be issued for the 2025 tax year.

What can be issued:

- Inhabitant tax (special city inhabitant tax and metropolitan inhabitant tax) certificate of taxation
- Inhabitant tax (special city inhabitant tax and metropolitan inhabitant tax) certificate of exemption from taxation
- Certificate of tax payment

Who can receive certificates:

People who were registered as residents of Ota City as of January 1, 2025, and filed tax returns

Requirements for issuance:

- When visiting the service counter in person
 - Personal identification (e.g., residence card, etc.)
- When someone representing you visits the service counter
 - Letter of Proxy (a Japanese translation will also be required if the letter is written in a language other than Japanese)
 - Personal identification of the person representing you

The Educational Consultation Office is ready to talk to you in person or by telephone about any questions or worries you may have concerning your child. Topics can include your child's education, personality or behavior, developmental disorders, experiences with bullying, and relationships with friends. The office can also talk to you about having your child attend Tsubasa classes.*

* "Tsubasa classes" are attended by elementary school students and junior high school students who are unable to attend school due to psychological reasons.

- Children/students who wish to attend Tsubasa classes
